The proposed budget includes sufficient funds to provide curriculum and instruction which will enable all students to achieve the New Jersey Student Learning Standards, and is compliant with N.J.S.A. 18A and N.J.A.C. Title 6 and 6A. The District has proposed programs and services in addition to the New Jersey Student Learning Standards adopted by the State Board of Education.

The 2023-2024 budget includes the use of all automatic adjustments \$553,828.00 <u>enrollment adjustment</u>.(i.e. enrollment and pre budget year tax levy), if applicable.

The 2023-2024 budget includes a withdrawal from the Capital Reserve in the amount of \$285,038.00. The use of these funds is for the lease purchase, video management server, cameras, boiler controls, truck, electric to pole barn, including architect and engineering fees. If all funds are not used by the end of the 2023-24 budget year, they must be returned to the Capital Reserve Fund by June 30, 2024.
